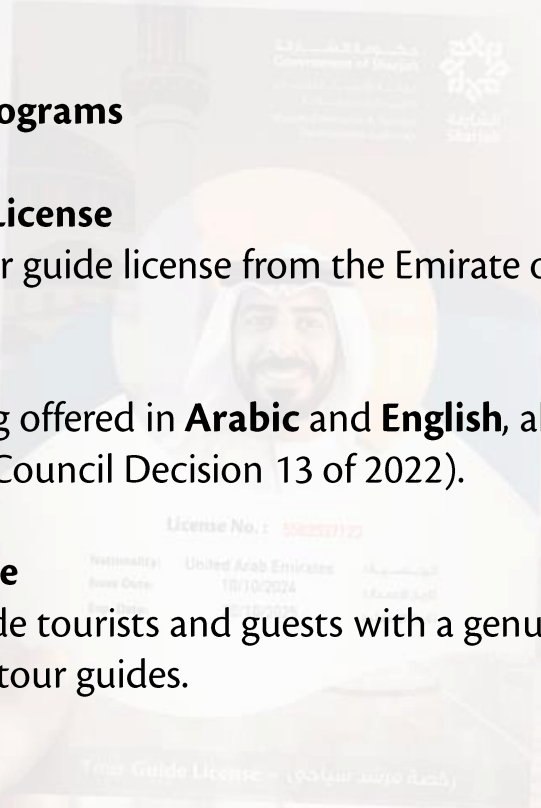

SCTDA Tour Guide Training Programs

Online Availability: Programs offered year-round.

For Beginners:

No license? Register for **Tour Guiding for Beginners**.

Renewal Eligibility:

- Must hold a Sharjah license.
- Expiry must not exceed **2 years**.
- If expired over 2 years, enroll in **Tour Guiding for Beginners**.

Advanced Course:

Do you hold a valid license from another emirate? Apply for the **Advanced Tour Guiding**.

Fee Waivers:

- **UAE Citizens:** Fees waived.
- **Children of Emirati Mothers:** Fees waived.
- **Government Employees:** Non-UAE citizens may have fees waived with an official letter to SCTDA (include nationality).

Tour Guiding for Beginners

This program aims at developing the skills required to be a successful tour guide. The principles of tour guiding includes information about history and tourist attractions of Sharjah, in order to deliver a memorable journey for visitors. Participants will achieve an official license to conduct valid tours in Sharjah upon completion.

Please note that the SCTDA Tour guiding for Beginners– Online is currently open and **you will have 3 months to complete from the date of enrolment**

Cost: AED 2,850 + AED 20.50 (Tas'heel and Government Research fees)

Advanced Tour Guiding

Aimed at further developing the skills required to be a successful tour guide in Sharjah, this training builds on the history and tourist attractions of Sharjah and provides licensed tour guides from other Emirates with an official license to conduct valid tours in Sharjah.

Please note that the SCTDA Tour guiding for Advanced tour– Online is currently open and **you will have 3 months to complete from the date of enrolment**

Cost: AED 2,100 + AED 20.50 (Tas'heel and Government Research fees)

Fee Waivers

Tour Guiding Renewal/Refresher

Renewal is offered annually by SCTDA for tour guides with SCTDA expired licenses. The training program is a recap of skills, information and updates on Sharjah destinations and attractions.

Please note that the SCTDA Tour Guiding – Renewal / Refresher – Online is currently open you will have 3 months to complete from the date of enrolment

Cost: AED 600 + AED 20.50 (including Tas'heel and Government Research fees)
